The validity of the NAAC grade of the Institute will expire on April 30, 2024 as per the certificate of accreditation. The SSR is being prepared so that the final submission can be done several weeks before the deadline.

As per NAAC norms, HEI has to apply for a subsequent cycle of accreditation during the last six months of the validity period. The IIQA has to be submitted within these six months and once the IIQA is submitted, the SSR has to be submitted within 45 days of the submission of the IIQA. The
