Inviting Quotation for Implementation, Data Migration, Training and Support Services on Koha (Open Source Library Management Software)

Eligibility Criteria for Vendors:

1. The vendor shall have minimum one year experience in Implementation, Data Migration, Training and Support Services on Koha (Open Source Library Management Software) on Linux platform as Library Management System in libraries and organizing trainings for day to day running of the software.;
2. The vendor must have installed, configured and commissioned Koha (Open Source Library Management Software) on Linux platform as Library Management System in at least 3 libraries (having minimum collection of fifty thousand documents). The vendors shall attach copies of purchase order and certificates of work completion as proof in the technical bid; You are also requested to provide us list of your major customers;
3. The vendor shall have *minimum turnover of Rs. Fifty lakhs* per annum during each of the last two years. Attested copies of income tax returns must be submitted with the technical bid;
4. The vendor should possess *valid VAT/CST/Service Tax Number*. Attested copies of the same must be submitted with the technical bid;

Technical Requirements:

1. Installation and configuration of Koha Open Source Library Management Software (latest stable/tested vanilla version) on Linux server.
2. Data migration from MySQL dump file of Libsys7 software to Koha with UNICODE and MARC21 support
 - Migration of Bibliographic records of catalogued, accessioned but not catalogued and those records on order and records of all document types, (around 1.1 lakh records).
 - Circulation data – members profile, documents borrowed, titles and members history of borrowing
 - Administrative data such as bills, orders, exchange rates, vendor, order date, accession number, accession date, etc. available in MySQL dump file.
3. Configuration and implementation of all the Koha supported modules such as Acquisition, Circulation, Cataloging, Serials, OPAC, Course Reserves, Reports, Administration, Patron, Tools, Lists, Authorities, RFID, Barcoding, and other standard utilities available in the Koha latest stable version.
4. Configuration of E-mail notifications through Gmail;

5. Please also mention fee for hosting the service on cloud, if provided;
6. Providing of certain SQL commands to generate reports as per the requirement of the library;
7. Onsite training for 3 days (2+1), 2 days training immediately after installation and testing and one day training at a later date;
8. The complete documentation on system setup, parameter setting, backend structure, software installation, trouble shooting, users' guides, etc., for the corresponding version used for installation;
9. AMC for one year after the successful commissioning of the software which includes upgrade to next stable version (subject to release), minimum of Six onsite visits and unlimited remote or online help through ticketing system; **AMC Charges will be paid half yearly.**
10. Delivery period - The project need to be completed within 15 days immediately after placing the orders.
