# Preface

IGIDR looks back on an eventful and successful year 2012. The year was especially important as the university successfully concluded 25 years of remarkable contribution in the field of research and education. IGIDR was inaugurated as an advance research institute in 1987 by the then Prime Minister Shri Rajiv Gandhi. Times have certainly changed since then as the institute has created campus and community for the 21st century and transitioned to become a center of excellence for higher learning in economics. IGIDR feels proud of the brand it has built, the culture it has created, the friends it has found, and the purpose it has pronounced. We invite you to explore IGIDR's accomplishments over the past year in our 2012 -13, Annual Report.

Together with our partners from the public and industrial sector, many important workshops and training programs and lectures were organized during the year. A workshop on "New Spatialities of Production: Impact on Work Organization, Labor Processes and Upward Mobility" was organized in collaboration with IHD, ICRIER and CTG (Capturing the Gains Initiative, Manchester University) between July 6-8, 2012. This was followed by the 8th Biennial Workshop of Advances in Energy Studies (AES) during October 25-27, 2012 which was dedicated to advances, innovation and visions in energy and energy-related environmental and socio-economic issues. During December 10-14, 2012, BIG (Bayreuth-IGIDR-Groningen) workshop on "Rationality, Decision and Evaluation" was organized in collaboration with Bayreuth and Groningen University. IGIDR also contributed towards organizing the 4th International Workshop on Quantitative Finance at IIT Kanpur during 22-25 December, 2012, together with Institute for Development and Research in Banking Technology (IDRBT), Hyderabad, Indian Institute of Technology, Kanpur (IIT Kanpur) and Rensselaer Polytechnic Institute, USA.

As a part of its Silver Jubilee Celebrations, IGIDR organized the International Conference on Development: Successes and Challenges Achieving Economic, Social and Sustainable Progress from December1-3, 2012. The conference served as a great platform for researchers across the board to discuss the multifaceted idea of progress and its past and future trends. There were sessions on Development, Economic Theory, Macro Economic and Finance, Trade and Industry, Energy and Environment and Agriculture and Rural Development, with the audience benefitting from the views of internationally renowned speakers such as Prof. T.N. Srinivasan (Professor Emeritus, Yale University), Prof. Ravi Kanbur (Professor, Cornell University), Prof. Kaivan Munshi (Professor, Brown University), Prof. Raj Chetty (Professor, Harvard University) to name a few. Special events such as the welcome reception, a lively panel discussion by present and former governors of Reserve Bank of India on India's Economic Prospects, a panel discussion on Indian Economic Policy Making: Successes and Challenges and a mesmerizing Hindustani classical concert by Padma Shree Smt. Shubha Mudgal were also enjoyed by all.

IGIDR also organized several Distinguished Silver Jubilee lectures and Silver Jubilee Short courses to mark its 25th anniversary. Several eminent academicians like Prof. Prasanta Pattanaik (Professor Emeritus, University of California), Prof. Martin van Hees (Professor, University of Groningen), Matthew Braham (Professor, University of Bayreuth), Professor Gabriel Wollner (London School of Economics), Prof. Cristina Bicchieri (University of Pennsylvania) and Prof. Avinash Dixit (Professor Emeritus, Princeton University) gave lectures as a part of the event. Complete details of events can be found in the section titled "Lectures, Workshops and Conferences".

Through intensive research and development work in all areas, faculty at IGIDR has been able to achieve results that make us proud and we have embarked on several opportunities that will have implications on our academic mission for years to come. A total of 41 research papers in international/national journals, 22 research papers in edited volumes, five edited books and three books have been published/accepted over



the last year. Faculty has also participated in important policy making committees and both the faculty and students have visited various academic institutions of international repute. The institute was also host to international students who were visiting for research.

Students are an integral part of IGIDR. They are encouraged to pursue their dreams and the university offers the infrastructure to accomplish their goals. The recreational and cultural aspects of student life are important to us and generous facilities are provided to take care of them. Apart from this the university also provides office space and intensive mentor-led guidance to its students. The 10th convocation of the university held on 11th Feb 2013, saw two Ph.D., three M.Phil. and 22 M.Sc. degrees being awarded. Shri Jairam Ramesh, Minister of Rural Development was the Chief Guest of the occasion, with Dr. D.Subbarao, President of the Institute and Governor, RBI, presiding over the convocation.

Our plan to improve facilities for our researchers, teachers and students has started to yield a visible impact. We have continued our program of up-gradation, and there has been progress in major infrastructure projects, most notably the upcoming new hostel which will benefit our students in the long run.

In 2012-2013, we bid farewell to Professor Manoj Panda, who left to join as Director of Institute of Economic Growth in New Delhi. We also welcomed Dr. Namrata Gulati who joined us as Assistant Professor in July 2012 and Dr. Taniya Ghosh who joined us as visiting fellow in March 2013.

We have met the challenges so far and will continue to enforce this process even further in 2013. We will also continue to focus and strengthen our overall research and development capabilities. The university as before will embrace the educational needs of the diverse socioeconomic populations that constitute the nation and will continue to deliver academic training and research from an interdisciplinary perspective.

Annual Report 2012-13

## **Research Themes**

This section offers a thematic overview of faculty research during 2012-2013 through summaries of select work. A detailed list of publications is available in the section titled "Faculty Research Publications".

### MACROECONOMICS:

Naveen Srinivasan with Pankaj Kumar and Pratik Mitra tries to explain the current inflation predicament for India. It is often claimed that stubbornly high inflation is because of "temporary factors or cost shocks" such as an increase in oil or commodity prices. According to this widely held view inflation is a purely nonmonetary phenomenon: it is driven by "cost-push" factors, and these factors dominate the behavior of inflation regardless of the course monetary or fiscal policy takes. Their research suggests a link between fiscal and monetary expectations which is often ignored by both policymakers and the popular press. In another work with Pankaj Kumar he investigates if credibility was an important determinant of inflation persistence using data for US and UK. He also examines the hysteresis in unemployment with Pratik Mitra.

Ashima Goyal explains the monetary operating procedures in the Indian context. Her research shows that as markets deepen and interest elasticities increase it is optimal for emerging markets to shift towards an interest rate instrument since continuing monetization of the economy implies money demand shocks are large. In her research on inflation and governance she performs a detailed examination of propagation mechanisms. She concludes that the best policies are those that reduce average production costs. In another work she presents a framework giving a new simple proof of the Balassa Samuelson result. If the assumption that the price level is fixed for the EDE is dropped, nominal depreciation interacting with different types of wage rigidities can explain higher inflation, as nominal wages rise in response to a nominal depreciation. Then monetary shocks have persistent effects but these shocks can arise from large capital flows independent of changes in domestic money supply. Evidence from India supports the hypotheses.

In another paper with Sanchit Arora, she examines India's potential growth from theory and structure. Estimates suggest that India's aggregate supply is elastic but subject to upward shocks. If supply shocks make a high persistent contribution to inflation, it implies that second round pass through is occurring, further implying that growth has reached its potential. This measure of potential growth draws on both theory and the structure of the Indian economy. It turns out that supply shocks largely explain inflation. Output reached its potential only in 2007-08 when growth rates exceeded 9 percent. In the period 2010-11 there was no sustained excess of growth over potential. Inflation was due to multiple supply shocks, rather than second round effects. Estimated linear and Markov switching policy rules suggest there was overcorrection in 2011. They show that a two percent underestimate of potential output leads to a 50 basis point rise in policy rates.

A. Ganesh-Kumar examines the food grain supply chains and inflation. Traditional supply chain studies typically trace the flow of commodities from producers to consumers. In doing so, they identify the roles of government institutions, infrastructure and intermediaries in the supply chain / price formation. These studies, however, have largely not examined the role of spatial factors (i.e., neighborhood effects) in supply chain/price formation. This new line of research seeks to explore this aspect. In particular it seeks to explore what, if any, role spatial factors play in price formation and hence food inflation.

Rupayan Pal with Kausik Gangopadhyay and Atsushi Nishimura examines the empirical phenomenon of co-movement of skill premium and stock prices. Analysis of both time series data from the US and panel data from six OECD countries reveal that these

two variables are cointegrated indicating a long run relationship. Calibration of the model based on reallife data shows that this simple model explains a large part of the change.

Dilip M. Nachane in his article "Global Crisis and the New Consensus Macroeconomics" reexamines the hybrid classical-cum-Keynesian theory - the so-called New Consensus Macroeconomics. The Global crisis was widely perceived as an outcome of some of the faulty policies implied by the NCM. This prompted a serious re-examination and criticism of the theoretical foundations of the NCM from four distinct schools of thought, viz, the post-Keynesian, Austrian, Structuralist and Marxist. The paper delves into the theoretical structure as well as the policy implications of the post-Keynesian critique of the NCM. Certain implications are drawn for macroeconomic policy and cautionary caveats are entered for the process of financialisation currently under way in several emerging market economies.

In another work with Amlendu Dubey, "Trend and Cyclical Decoupling: New Estimates Based on Spectral Causality Tests And Wavelet Correlations", he tackles the issue of decoupling of emerging market economies (EMEs) (especially in the Asian region) from the developments in advanced economies. Decoupling seems to comprise three sub-hypotheses: (i) growth spillovers from advanced countries to EMEs decreasing progressively in importance, (ii) business cycles in EMEs becoming less synchronized with those of the advanced world and (iii) strengthening of growth spillovers and cyclical synchronization among the EMEs as a group. The received literature fails to distinguish adequately between the trend and cyclical aspects of the decoupling relationship. The duo resorted to two frequency domain methods (nonstationary spectral causality testing and wavelet correlations), which seem to offer a neat separation of trend and cyclical decoupling. Based on a sample of seven EMEs from the Asian region (including the two large EMEs - China and India), they uncover strong evidence favoring both trend and cyclical decoupling.

### **BANKING & FINANCE:**

Rajendra Vaidya with Vikash Gautam analyzes the growth and finance constraints in Indian manufacturing firms. For a sample of 2282 Indian manufacturing firms in the period 1994 to 2009, they show that the growth process of firms does not follow normal distribution; growth of firms is persistent and; size, maturity and finance constraints negatively influence the growth of firms. They check the robustness of results using alternative samples, firm growth measures and estimation techniques.

In another paper they examine the evidence on the determinants of investment-cash flow sensitivity. They investigate these issues using a sample of 2676 Indian manufacturing firms over the period 1994 to 2009 and use firm level estimates of ICFS to sort firms into positively cash flow sensitive (PCF-sensitive) group, cash flow insensitive (CF-insensitive) group and, negatively cash flow sensitive (NCF-sensitive) group. They find that all three groups of firms start with high levels of investment, but only the PCFsensitive firms have high level of cash flows. With age, the investment of all three groups of firms remains stationary. But for CF-insensitive firms only the cash flow rises with age. Further, they use a multinomial logistic regression to study the determinants of ICFS in the three groups. The results suggest that the interpretation of NCF-sensitive, PCF-sensitive and CF-insensitive as distressed, financially constrained and financially unconstrained, respectively, can be contested by the data.

R. Krishnan and Vinod Mishra study intraday liquidity patterns on the National Stock Exchange (NSE) of India. Using trade and quotes data on stocks contained in the NIFTY index, they find that most of the volume and spread related to liquidity measures are U-shaped, similar to those found in a quote driven market. Such patterns also indicate a contradictory



feature of concurrent high trading volume and wide spreads, a feature that is new to an order driven market such as the NSE.

Ashima Goyal with Shruti Tripathi in a study of oil prices and regulation applies time series tests for mutual and across exchange causality and leadlag relationships between crude oil spot and futures prices on two international and one Indian commodity exchange. They also search for short duration bubbles, and how they differ across exchanges. The results show that expectations mediated through financial markets did not lead to persistent deviations from fundamentals. There is mutual Granger causality between spot and futures and in the error correction model for mature exchanges, spot leads futures. Mature market exchanges lead price discovery. Futures in these markets lead Indian (daily) futuresmarkets. But there is stronger evidence of shortterm or collapsing bubbles in mature market futures compared to Indian, although mature markets have a higher share of hedging. Indian regulations such as position limits may have mitigated short duration bubbles. It follows leverage due to lax regulation may be responsible for excess volatility. Well-designed regulations can improve market functioning.

In another work, she assesses the sources of risk for Indian banks in the context their history, structure and level of development. She finds that the scale and cross-border exposures for banks in emerging economies are lower compared to advanced economies. The path of market development and regulatory evolution has helped reduce structural risks but some of the distinctive broad-pattern regulation used creates incentives that could fill gaps in global regulatory reforms if more widely applied. Since markets remain thin, and interest rate spreads are high, banks in emerging markets are vulnerable to large fluctuations in policy rates. Cyclical risks can be contained as long as policy makers moderate the rates. Global regulatory reform can also reduce risks. The argument is illustrated with the Indian case.

In an additional paper, she examines financial liberalization in three South Asian countries— Bangladesh, India and Pakistan — in order to derive lessons for future reforms. It investigates how freeing domestic financial markets, improving capital account convertibility, and restructuring regulations have impacted the process of financial liberalization in South Asia. The paper shows that the capital account was most liberalized in Pakistan, and that Bangladesh had the least market development of the three countries under consideration.

Rupayan Pal with Satya Chakravaty develops an axiomatic measure of financial inclusion. This measure is readily implementable and useful to determine policy priorities to promote financial inclusion. They demonstrate that supply side data on banking services can be usefully employed to measure financial inclusion and also examined the effects of major banking policies on financial inclusion across states in India during 1972–2009, using panel data econometric techniques. This paper identifies geographic penetration of banks and credit availability as two policy targets to foster financial inclusion in India.

### **MICROFINANCE:**

Susan Thomas with Renuka Sane studies regulation in the field of microfinance. Recent events in India have brought a fresh focus on the appropriate regulatory stance towards micro-finance. In this paper, they review facts and recent experience of Indian microfinance. They analyze the puzzles of financial regulation in this field from first principles, and argue that the mainstream mechanisms of consumer protection and micro-prudential regulation need to be modified owing to joint-liability groups. From this perspective, they suggest regulatory strategies that need to be adopted for dealing with micro-credit and financial distribution that focuses on the poor. This analysis and conceptual framework also helps analyze the two policy responses till date, the Malegam Committee Report and the draft Microfinance Bill, 2011.

In another paper with Rajat Tayal, she works on measuring and explaining the asymmetry of liquidity. This paper examines transactions costs in buying versus selling using a large database of snapshots of the limit order book. On the equity spot market, there is clear evidence of asymmetry in liquidity: transaction costs are lower for buy market orders when compared with sell market orders. In the identical setting, trading in single stock futures is also observed, and there is little evidence of asymmetry. This suggests that asymmetry in liquidity may be driven by short sales restrictions which are present on the spot market but not on the single stock futures market.

With Nidhi Aggarwal and Manish Singh, she examines the changes in distance-to-default to anticipate changes in the credit rating. Distance-to-default (DtD) from the Merton model has been used in the credit risk literature, most successfully as an input into reduced form models for forecasting default. In this paper, they suggest that the change in the DtD is informative for predicting change in the credit rating. This is directly useful for situations where forecasts of credit rating changes are required. More generally, it contributes to our knowledge about reduced form models of credit risk.

### LABOR AND EMPLOYMENT:

A. Ganesh-Kumar in his paper with Eduardo Zepeda, Scott McDonald, Manoj Panda and Chandan Sapkota, studies India's rural employment guarantee schemes. He examines the macroeconomic and distributional implications of the program .He also studies the economic and distributional consequences of partially diverting the program benefits away from the poorest rural households. This study explores these questions using a Computable General Equilibrium (CGE) model of the Indian economy.

S. Chandrasekhar in his paper with Ajay Sharma highlights the issue of internal migration for education and employment among youth (15-32)

years) in India. In the light of the evidence, they discuss the issue of internal brain drain where some states are gaining human capital (in terms of youth migrant workers with skills and education) at the expense of other states. When examined from an all-India perspective these movements would not be a problem but from the perspective of the states these movements can affect growth trajectories and potential economic development. This aspect needs to be highlighted in the discussions on inclusive growth and development.

They have additionally tried to identify the key knowledge gaps on the issue of migration and commuting workers in India.

K.V. Ramaswamy studies workers in the unorganized sector excluding self-employed using results from two NSS surveys separated by 5 years (2004-05 and 2009-10). In this descriptive paper he examines the growth of real wages of wage-labor in the unorganized sector in India excluding agriculture. He studies two standard worker categories, namely, regular wage workers and casual workers. The results of this paper suggest that relatively high economic growth could benefit both regular and casual workers in India.

another paper Ramaswamy studies In the phenomenon of the missing middle in Indian manufacturing. He explains the role of size dependent labor regulations and fiscal incentives in understanding the missing middle in the Indian manufacturing. The missing middle in the size distribution of firms refers to the thin share of employment size class 50 to 499 in Indian manufacturing employment. This paper argues that the problem of missing middle is an outcome of threshold effects of labor regulations defined by employment size and fiscal incentives determined by turnover size for small-scale enterprises. The empirical results support the threshold effects of size dependent labor regulations and fiscal incentives.



### FOOD AND AGRICULTURE:

G. Mythili models the impact of agricultural growth on consumption and nutrition. Using General Equilibrium Modeling, her study proposes to find the connecting path of agriculture and nutrition via income and consumption. The existing data base is inadequate to analyze this. The latest Social Accounting Matrix (SAM) was further split in agriculture commodities to suit the analysis. Capital was further split into land, agricultural capital and non-agricultural capital to facilitate implementation of varying growth of agriculture and other capital.

She also studies different GDP growth scenarios projected for the future block years 2009-10 and 2019-20 using 2006-07 as the base year based on Computable General Equilibrium models and to find the GDP growth impact on sectoral growth, sectoral output, household consumption and income distribution.

S. Mahendra Dev, Srijit Mishra and Vijay Laxmi Pandey contextualize Indian agriculture by an evaluation of its performance, the roles and challenges for smallholders, and opportunities.

Srijit Mishra in his work with A. Ravindra and Ced Hesse studies rainfed agriculture. He shows in the paper that a new macro policy that articulates the need for decentralized, location-specific, integrated approaches in its rainfed areas is necessary for agriculture to be inclusive, climate-resilient and sustainable, and to provide the food and nutritional security that India needs.

S. Mahendra Dev and Vijay Laxmi Pandey analyze the Performance and Key Policy Issues of Indian Agriculture.

Vijay Laxmi Pandey is also working on tackling the "Agriculture and Nutrition Disconnect in India -Phase II" (TANDI II) project which is supported by Bill and Melinda Gates Foundation. TANDI-II aims to

contribute to the reduction of hunger and malnutrition among India's poor by increasing the evidence base for understanding the strength and dynamics of the multiple pathways between agriculture and nutrition and to provide tools to decision makers to strengthen the pathways from agriculture to nutrition

S. Mahendra Dev in India Migration Report: Global Financial Crisis, Migration and Remittance analyzes the impact of food inflation and the financial crisis in India on women and children. In another paper he examines the role of agriculture in securing nutrition in India. His other works focus on rising food prices in South Asia and the performance of Indian Agriculture and its key policy issues. In India Development Report he analyzes India's reforms giving an overview of the India's experience with the reforms. In one of his papers he examines the issue of linkages between agriculture and nutrition, outlining some key entry points for agriculture to influence nutrition.

Sudha Narayanan's current work pertains to examining different aspects of contract farming practice in southern India using survey data collected between 2007 and 2010. In several papers this year, she explores select aspects of contract farming, the firm's procurement strategies, farmer's choices on whether or not to contract and the impact of contract farming on incomes of participating farmers. She has also explored smallholder market linkages via marketing cooperatives.

A. Ganesh-Kumar is currently working on accelerating agricultural productivity growth in India in research sponsored by World Bank, New Delhi. In his research he examines India's considerable progress since the 1960s in securing food grain availability. Productivity enhancement through technology adoption supported by a blend of policies and institutional arrangements has been central to bringing about this achievement. Despite its past success the country faces immense challenges in ensuring future

food security for its citizens. He argues that past policies of providing subsidized inputs have given rise to inefficient and environmentally unsustainable farm practices in the traditionally net-food surplus regions of North-West India. His study seeks to explore policy options for accelerating agricultural productivity growth in India. Specifically, it examines the spatial impacts of alternative policy options using a new spatial computable general equilibrium (CGE) model of India. This spatial CGE model, possibly the first of its kind for the Indian economy, is based on a Regional Social Accounting Matrix (SAM) for 2006-07 that has been constructed specifically for this study. The model is currently under development.

# POVERTY, INEQUALITY AND HUMAN DEVELOPMENT:

A paper by Shovan Ray's on economic inequality and the Kuznets process will be published in a book edited by R. K. Panda and Rajkishor Meher that examines the trends, magnitude and dimensions of inequality in Post Reform India. In a separate research programme, he is the lead author for chapters on "Inclusion and Social Sector" and an Editor of India Rural Development Report, a new initiative of and part funded by Ministry of Rural Development, Government of India and IDFC. In another paper he studies the education for development of India in the Asian perspective.

Srijit Mishra with J.F. Levesque, S. Mukherjee, D. Grimard, and A. Boivin measures the prevalence of chronic diseases using population surveys by pooling self-reported symptoms, diagnosis and treatments: results from the World Health Survey of 2003 for South Asia. The research shows a robust relationship with self-rated health descriptions. The measure of chronic disease which they developed could form a basis for surveillance of chronic diseases in countries where health information systems have been poorly developed. It represents an interesting trade-off between the bias associated with usual surveillance data and costs.

In another work with Durgesh C. Pathak, he critically discusses the new method of measuring poverty. In doing so, it raises some concerns implicit in the report. They emphasize on the need to come up with multidimensional measures of poverty. Nevertheless, the paper contends that the approach followed in the report is pragmatic, but some additional information could have been put in the public domain to take the debate beyond the poverty line. Appropriate planning and implementation will require complementing this information with quantitative and qualitative information at the district and sub-district level.

They revisit the properties of group differential (GD) measures and extend it to include monotonicity and policy sensitivity axioms in another paper with Hippu Salk Kristle Nathan. Imposing level sensitivity, which indicates that a given gap is worse off at higher (lower) level of attainment (failure), the study concurs that 'simple difference' and 'simple ratio' are the most basic GD measures for attainment and failure indicators, respectively. They propose two new measures, one each for attainment and failure, which have certain advantages from a policy implication perspective. An empirical illustration has been provided by taking two indicators from Millennium Development Goals for different regions of the world.

Srijit Mishra and Nirmal Sengupta in their work give the first comprehensive post-facto impact assessment of PRADAN "to understand and estimate the nature, quality, extent and significance of (their) developmental interventions in the villages." The study points out that impact of PRADAN has been effective and positive, but it needs to improve its system of reporting and data collection.

Sripad Motiram with Vamsi Vakulabharanam tried to bring quantitative and qualitative approaches together for understanding poverty and inequality in urban India since reforms. Both quantitative approaches and qualitative methods were used to



study and measure the rising levels of inequality and the extent of poverty of the cities. While both have their problems, their paper claims that notwithstanding their respective limitations, these two approaches have captured different dimensions of the complex Indian urban process, even if they have rarely made an effort to speak to each other.

He also highlighted the plight of commons in the peasant economy of Karimnagar in Telangana, which have been endangered by quarrying and in one of his paper he argues that the commons are neither properly understood in this country nor are there adequate rules to govern them.

Sripad Motiram and Karthikeya Naraparaju investigated the relationship between growth and deprivation in India, an issue of immense interest. Given the continuing controversy in India over poverty lines, they use a framework that rigorously assesses the impact of growth on the poor over a range of poverty lines. Using National Sample Surveys on consumption expenditure, they show that while growth has "trickled down" in both rural and urban areas, it has not been in favor of the poor. In urban areas, growth has been "anti-poor. Their findings raise serious concerns about the "inclusiveness" of Indian growth.

In another work with Vamsi Vakulabharanam, he examines the patterns and changes in Indian Inequality from 1993-2010 using the NSS Consumption expenditure data. They show that overall, the growth process has been associated with increasing inequality both at the rural and urban levels and states that have seen higher growth rates have also seen bigger increases (or smaller reductions) in inequality.

M.H. Suryanarayana and R. Nagaraj study growth, inequality and social development in India. They show that even India has embarked upon a strategy of development planning to achieve 'Growth with

Redistribution'. The Plan priorities and strategies have varied across successive five-year Plans depending upon the emerging constraints and policy imperatives. Economic growth, as measured in terms of 'rate of growth of per capita gross national product', has been quite limited till recently. Following the conventional approach, their study has utilised estimates of consumption distribution. Estimates of inequality in consumption distribution carried out with limited feasible methodological refinements like price-adjustments for changes in relative prices and inflation, and statistical corrections for grouping bias do not reveal systematic trends or any evidence of redistribution.

M. H. Suryanarayana's work on Somalia is a review of national economic policy framework, its information base (National Accounts Statistics), Poverty Monitoring System and its information base in Somaliland, Puntland and South Central Somalia respectively. In the light of this assessment, it proposes a framework for Poverty Monitoring and Analysis System for Somalia and develops an implementation strategy. It provides illustrations based on available information for the three administrations of Somalia. The report provides illustrations of feasible Poverty Monitoring and Analysis system (PMAS) given data constraints for each of the administrations. These illustrations provide convincing evidence of the need for a sound information base for national economic policy and PMAS in Somalia.

R. Nagaraj worked on the inclusive growth in India. He edited the book "Is Inclusive Growth Possible in India? Growth, Inequality and Social Development" for United Nations Research Institute for Social Development, Geneva, 2012.

In one of his works he studies the boom and its aftermath. He revised the "Patterns of Growth and Development of Indian Industry", for a volume on "Indian Industry", edited by C. P. Chandrasekhar, for the ICSSR.

Namrata Gulati with Abhimanyu Dadu in their paper, "Inequality, Neighborhood and Variation in prices" examines the link between income distribution and prices of grain. They obtain weekly time series data on prices for wheat for 3 districts in Uttar-Pradesh from the Department of Economics and Statistics of the Ministry of Agriculture, Government of India (DES-MOA, GOI) for the period 2006-2011. Data on Gini comes from National Sample Survey of India. They find an inverted-U shape relation between inequality and level of price for food grains: if one compares a cross-section of societies, then price of food grain initially increases with increase in inequality and starts declining as inequality increases. The result is important as it holds even when the good is not differentiated on the basis of quality.

Namrata Gulati in her other work with CSH in Delhi has been involved in collecting primary level data from different slums in Mumbai. The idea that she wishes to explore is whether the government needs to physically provide the infrastructure or it can provide information and vouchers which can be exchanged with the private set up.

### **ENERGY AND ENVIRONMENT:**

B.Sudhakara Reddy and Hippu Salk Kristle Nathan examine the importance of Energy in the development strategy of Indian households. In another paper, they work towards a conceptual framework for development of sustainable development indicators for an urban setup. They also work on energy infrastructure for a high humane and low-carbon future. They try to analyze whether we can break our addiction to fossil energy.

B. Sudhakara Reddy continued to work on the urban metabolism. His work lays emphasis on the metabolism of Mumbai. In his work he argues that urban areas cover less than 1% of the world but they host over 50% of the world's population. His study provides an analytical framework for accounting of urban stocks and throughputs and helps understand critical processes as well (increasing or decreasing ground water resources, long-term impacts of

hazardous construction materials, etc.). The main findings and recommendations of his case study based on Mumbai underpin efficient resource urban policy and design, as well as enhance sustainable production and consumption.

In another work, Dr.Reddy investigates if the present pattern of urban development in India in the creation of mega cities is sustainable. This has been done by comparing the indicators of Indian cities Mumbai and Bangalore with those of sustainable mega cities of developed countries (Shanghai, London, and Singapore). He also performs a comparative analysis of megacities of India with P. Balachandra.

Sudhakara Yedla reviews and assesses Urban Forestry and Ecological Services in an Indian metropolitan city. Based on the WHO standards for the green cover per capita (9 m2 of green open space per unit dweller), the paper tries to estimate on how much green cover needs to be restored in the city. Finally, the paper estimates the eco-system services of such restored Urban Green Cover in terms of greenhouse gases mitigation, pollution control, and other more intangible outcomes.

In another paper on environmental management, he attempts to understand the model, necessary conditions, strategies and their priorities to replicate Dhaka's community-based decentralized composting (DCDC) in other developing cities of Asia. Based on the analysis, measures to ensure the product quality control; partnership among stakeholders (public–private–community); strategies to achieve better involvement of the private sector in solid waste management (entrepreneurship in approach); simple and low-cost technology; and strategies to provide an effective interface among the complementing sectors are identified as important strategies for its replication.

Vinod K. Sharma continued his research as an expert work group (WG) member of the National Insitute of Advanced Science and Technology (AIST), Japan and the Economic Research Institute



for ASEAN and East Asia (ERIA), Indonesia. It is a multi-disciplinary, multi-national expert work group that supervises and suggests investigations on various aspects of "Sustainable Biomass Utilization for Energy Production in East Asia," including India. The WG experts are specialized in various disciplines such as energy, environment, social-sciences and economics, within the East Asian (EA) region. WG has supervised several field studies conducted on social, economic and environmental aspects of sustainability of biofuels (ethanol and biodiesel), in India, Indonesia, Japan, the Philippines and Thailand and continued their research on data and information during 2012-2013. The WG's annual report, gives policy recommendations for the Energy Ministers' of the EAS countries including India.

Rupayan Pal examines how product differentiation as well as strategic managerial delegation affects optimal emission tax rate, environmental damage and social welfare, under alternative modes of competition. He shows that, under pure profit maximization, the optimal emission tax rate is not necessarily decreasing in degree of product differentiation. Moreover, the impacts of delegation on the scope for the optimal emission tax rate to be lower for higher degree of product differentiation are very different under alternative modes of competition. Under price (quantity) competition, the equilibrium emission tax rate, environmental damage and social welfare are lower (higher) in the case of delegation.

### **INTERNATIONAL TRADE:**

C. Veeramani compares the performance of India's exports with that of China. Drawing upon the experience of China's export success in manufacturing, his paper provides some explanations to the lackluster performance of India. In his work he shows that government interventions in the factor markets have had the unintended consequence of creating a bias in the incentive structure against labor intensive manufacturing. The main finding of the paper is that vertical specialization has been discouraged in India on account of restrictive labor laws, inefficient infrastructure, burdensome regulatory environment,

inefficient land acquisition process and poor trade facilitation.

### **INDUSTRIAL ORGANIZATION:**

Rupayan Pal in his paper with Ritika Jain investigates the effects of cross-ownership on optimal privatization, and vice-versa, in mixed duopoly. They show that cross-ownership is profitable to the private firm only if the level of privatization of the public firm is sufficiently high. In equilibrium, cross-ownership does not take place even if there is partial privatization. However, the possibility of crossownership significantly limits the socially optimal level of privatization in most of the situations. Moreover, they demonstrate that full nationalization is socially optimal, in case of sufficiently convex identical cost functions and homogeneous goods. These results have strong implications for both divestment and competition policies.

In another paper with Trishita Bhattacharjee, he shows that network effects do not have any implications for the nature of the equilibrium strategic managerial delegation under Cournot type quantity competition, unlike in the case of Bertrand type price competition. They also show that delegation of output/price decision to the manager is optimal for the owner even in the case of monopoly in the product market, due to the existence of network effects. The monopolist offers sales-oriented incentive scheme to her manager in equilibrium, if there is network effect.

### POLITICAL ECONOMY:

Rupayan Pal with Arun Kaushik examines the effects of political factors on allocation of revenue budget for developmental expenditure by the sub-national governments, using data from 15 major states in India during the period 1971-2005. They measure the ruling party's political stronghold on the basis of constituency level electoral outcomes and shows that greater stronghold of the ruling party in a state leads to significantly higher proportion of revenue budget allocated for developmental expenditure. They also show that voters' turnout and political regime change have positive and significant effect on proportion



of revenue budget allocated for developmental expenditure. However, political ideology, within government fragmentation, disproportionality in representation, and effective number of political parties do not have any significant impact on budget allocation decisions of the Indian state governments. The new and robust results of this paper also indicate that greater reliance on market forces reduces the share of developmental expenditure.

PG Babu with Mahendra Dev, Sripad Motiram, R. Nagaraj, Pranab Bardhan, Louis Tillin and Sunil Khilnani developed a proposal on Indian Political Economy which was selected for UK-India Education and Research Initiative (UKIERI) Funding for the period 2013 and 2014.

### **CORPORATE GOVERNANCE:**

P.G. Babu in his work examines the study of Karnataka's institutional mechanism to prosecute corruption. He further suggests that the best case for a Lokpal is to show that existing Lokayuktas in the states are performing satisfactorily. He examines the comprehensive data of the cases handled by Karnataka's Lokayukta between 1995 and 2011. In his work he shows that at present the design of anti-corruption ombudsman leaves a lot to the personality of the Lokayukta and presents an incentive structure that does not support a sustained drive against corruption.

Jayati Sarkar and Subrata Sarkar continue their work on the evolving system of corporate governance in India with particular focus on the developments since the country embarked on the path of economic liberalization in the early nineties. Their work provides an overview of the various committees and codes that have shaped the governance standards in India and a comparative assessment of these standards with international best practices. A corporate governance report card in terms of trends in key governance indicators and an overall corporate governance Index is presented for top 500 listed companies. Both the comparative assessment and the report card show a significant improvement in governance practices in Indian companies. Their research concludes by noting that while the governance reforms in India have emerged in line with international best practices there is still a need to improve enforcement so that better governance systems translate into better economic outcomes.

# GAME THEORY AND EXPERIMENTAL ECONOMICS:

Shubhro Sarkar's major work is on applied game theory and experimental economics. In one of his papers with his co-author, he examines bargaining order and delays in multilateral bargaining with asymmetric sellers. In a multilateral bargaining problem with one buyer and two heterogeneous sellers owning perfectly complementary units, they find that there exists an equilibrium which leads to inefficient delays when the buyer negotiates with the higher-valuation seller first and where players are extremely impatient. They also find that the buyer prefers to negotiate with the lower-valuation seller first, except in equilibrium where both the buyer and the lower valuation seller choose to play "tough" strategies. These bargaining processes are applicable to a number of real-world applications, such as, land-acquisition, а manufacturer bargaining with upstream suppliers and a manager bargaining with two different unions in order to end a strike. He is also working on an experiment which studies behavioral decision making with uncertain outcomes.

## **Library and Information Services**



The IGIDR library is rapidly emerging as one of the leading professional research and reference libraries in the country. All bibliographic details of books, journals and CD-ROM databases are accessible through the campus-wide Ethernet network. The library has over **94365** printed documents and it subscribes to over **483** national and international journals.

It has established contacts with over 100 national and international organizations for exchange of the Institute's publications and inter-library loan arrangement. The institute library also has an account with BLDS under GDNET programme to meet its inter-library loan requirements.

The library homepage on internet provides links to various websites, which are of importance to economists. Access to electronic journals, union catalogue of periodicals, library catalogue, journal holdings, current journals, etc. have also been provided from this homepage. The theme 'Indian Economy' provides links to various internet resources related to Indian economy.

The library has developed an online **Union catalogue** of journal holdings, the data for which comes from 18 major Business and Economics libraries of the country. The union catalogue provides a platform for sharing resources among selected libraries. Under its online portal '**Open Index Initiative**' the library has developed a searchable database for index to articles published in Indian social science journals. The database contains about **78000** records covering more than twelve years data (2000-2012).

The library has given due consideration to the most modern approach for building its collection. The **Electronic Library** is blooming with an initial



collection of **9597** documents and is accessible through the campus network. It aims to collect articles, discussion/working papers, books, etc, which are available in public domain. It also intends to have in its collection all the theses submitted to the institute by M.Phil. and Ph.D. students. The library has also developed the Institutional Repository '**Kautilya**' using open source software **DSpace**. The repository contains full text working papers of the institute, abstract of theses submitted to IGIDR and proceedings of conferences organized at and by IGIDR.

## **Computer Facilities**



The computer facilities at IGIDR include a state-of-the-art technology computer center with latest hardware, networking equipment, software and help desk facilities. The entire office campus is networked by Ethernetbased LAN on fiber optic segmented backbone and connected to Internet through 20MBPS leased line. Important campus locations are also served by wireless network. The institute has Intranet, VPN access and provides messaging and collaboration services through Google Apps for all the users. The campus network has been extended to the residences of the employees.

#### Hardware

The computer center is equipped with high-end HP ITANIUM servers , HP NAS server, IBM X series server with VMWARE virtualization and Intel based multimedia workstations, CISCO switches, routers, Firewall for campus wide network connectivity. In addition to several multifunctional printers (MFP) in the faculty and staff offices, the printing facilities also include high-speed Network HP Laser printers, in each office block including the computer center (CC). The CC also provides total backup solution for users data through various backup devices viz., DAT, CD/DVD writer, and LTO-2 tape drive. Color scanners, visualizers and LCD projectors have been provided to assist the users in creating and presenting multimedia presentations.

#### Software

The servers are powered by LINUX, Windows Server Operating systems and the workstations are loaded with Linux (viz., Ubuntu, Fedora,), Windows 7 / XP/ OS. The CC provides all standard Econometrics and Statistical packages such as SAS, RATS, CATS, GAUSS, STATA, LIMDEP, MATHEMATICA, MATLAB and GAMS, EVIEWS under Unix/Linux and windows environments and office automation packages like MSOFFICE, LATEX, ADOBE ACROBAT under Unix/Linux/Mac and Windows environments.

In addition to the above software, the institute subscribes to corporate databases such as PROWESS, CAPITAL LINE, INDIASTAT.COM and various other national and international databases.

The computer center conducts various training and orientation seminar/lectures on several computer related topics, software, databases and on new IT technologies implemented at the institute to enhance and upgrade the computer skills of the user community of IGIDR.


