**I.** The following clauses are included as part of “SECTION-E, TECHNICAL BID” of the Tender Document-

**22.** Advertisement in the Classified:

The Classified advertisement should be considered a Classified Display (3cm width). The Recruitment Advertisement and Tender Advertisement shall be published under Classified Display.

**II.** The following line item is included in the Financial Bid-

**1. The bidder has to quote a rate in the Financial Bid for an additional newspaper, “*The New Indian Express*”.**

**2.** The rate should be quoted in a separate financial bid form attached to the corrigendum.

**III.** The following clauses are explained/modified for the Tender Financial Bid Form-

**1.** The classified advertisements shall be considered “Classified Displays” (3cm width).

**2.** The bidder should quote separate rates for the Recruitment and Tender advertisements under classified

Display.

3. The bidder should offer their separate discount as a percentage, including publication and agency discounts on the card rates of the various advertisements in the newspapers.

**IV.** All other terms and conditions of the Tender Document shall remain unchanged.

**V.** **The last tender bid submission date is extended up to the End of the Day on 30<sup>th</sup> April 2026.**
