CORRIGENDUM NO. 1

NIT No. IGIDR/Tender/2022/ED/05 Dated: 24th January 2022.

Tender Name: Selection of agency for conducting entrance examination of IGIDR for Year 2022.

This Corrigendum No. 1 is being issued to the Advertisement Notice for inviting Tender dated 24th January 2022 (the “**Tender Document**”), superseding and substituting the following in the tender document, with rest of the terms of the tender document remaining in force. The Corrigendum No.1 is part of the Tender Document and is to be read accordingly. All bidders are requested to acknowledge this Corrigendum No.1 as part of the tender Document before opening of the technical bid.

- I. The following clauses are included as part of “SECTION-E, TERMS AND CONDITIONS” of the Tender Document-

8. PENALTY/LIQUIDITY DAMAGES:

The services shall throughout the stipulated schedule of the contract mutually agreed by successful bidder and IGIDR be preceded with all the due diligence and if the service provider fails to complete their services within the specified period/schedule, the successful bidder shall be liable to pay compensation for delay at the rate of 0.5% per week subject to a maximum of 10% of the total contract/invoice value. The successful bidder shall before commencing prepare a detailed schedule which shall be approved by the Institute's.

9. INDEMNITY:

- a. In case the Service provider fails to fulfil the obligations as per the terms and conditions of the contract, the IGIDR may impose penalty to the extent of 100% of the total payment due for that Center Based Examination. In addition, the Performance Security may also be forfeited.

b. In case of non-fulfilment of the service provider's specific obligation as under the contract, which non-fulfilment leads to data loss/ non-compliance of event based log/ data saving. The service provider shall indemnify IGIDR to the extent of any loss suffered by IGIDR as a result of such data loss/non-compliance of event based log/data saving. However, the total liability of the service provider under this clause as well as under any other clause of the contract shall be limited to total amount payable by IGIDR to the service provider (under the terms of the contract).

II. The clause No. 1, SECTION-D, SPECIAL CONDITIONS of the Tender shall be replaced as follows-

In case the successful bidder contravenes any provisions of the law, and the Institute suffers any damage or loss or harm due to any acts of commission or omission of the successful bidder, the successful bidder is bound to indemnify the Institute. The successful bidder shall also be responsible for the discharge of all legal liabilities towards the Institute and also for observing all laws and Government rules relating to labour laws. However, the total liabilities of successful bidder under this clause shall be limited to total contract/invoice value.

III. The **clause No. 5 of Section-E, TERMS AND CONDITIONS** of Tender shall be replaced as follows-

5. Payment Terms:

- a. 25% of payment shall be payable on completion of database of all the applications and generation of report for issued Admit cards to the number of registered candidates.
- b. 25% of payment shall be payable after successful conducting of the center based examination.
- c. 50 % of payment shall be payable within 30 days of finalization of merit list of examination and handing over of all the relevant data/reports.

IV. The clause for Technical Bid Evaluation of SECTION-C, BID EVALUATION CRITERIA, the credentials related to experience for evaluation shall be read as-

The experience for conducting center based examinations shall be considered for exams conducted PAN India centers only.

V. The following clauses of the Tender are not applicable and shall not be considered as part of the Tender-

- a. Video Surveillance at location (Page No. 18 of the tender) - g) The front area and the back area of the Examination Venue.
- b. Standard feature in Software (Page No. 18 of the tender) – Virtual Numeric Scientific Keypad
- c. The provision of mobile jammers (Page No. 23 of the tender).
- d. Videography of examination (Page No. 15 of the tender).

VI. The last date for submission of tender bid is extended up to 03:00 PM on 17th February 2022.
