SECTION-A GENERAL INSTRUCTIONS TO BIDDERS

- 1. Expression of Interest (EOI) should be addressed to The Registrar, Indira Gandhi Institute of Development Research, Goregaon (East), Mumbai-400065.

The scan copy of EOI bid to be submitted through Email to tender@igidr.ac.in with subject of email should be mentioned as- "Expression of Interest for Empanelment of contractors for Civil & Electrical Works at IGIDR" respectively. All the required documents should be scanned and merged either into a single PDF file or zipped into a single file and attached to the Email. The bid file should be attached as a PDF document/zip file. In case bid file is protected with a password; the password to be shared at the time of bid opening through online meeting. The bidder should keep their password securely with them and required to give only in online meeting for bid opening.
- 3. The EOI will be received up to 03:00 PM on 2nd December 2021. Each copy of the EOI document under their stamp and signature. No bid will be accepted after due date under any circumstances whatsoever.
- 4. The Email bid with subject "Expression of Interest for Empanelment of Agencies to Provide Manpower on Outsourcing Basis at IGIDR" shall be opened by REGISTRAR or his authorized representative in his office on the next day 3rd December 2021 at 11:30 AM through online meeting platform. The link of meeting will be shared with participated bidders. In case, holiday is declared by the Government on the day of opening the bids, the bids will be opened on the next working day at the same time.
- 5. EOI shall remain valid for acceptance by the Institute for a period of Three months from the date of opening of the bid and the bidder shall not cancel or withdraw the quotation during this period.
- **6.** The bidder must use only the bid documents issued by the Institute. Any addition/alteration in the text of the EOI form made by the bidder shall not be valid and shall be treated as null and void.
- 7. Each Page of the EOI document should be signed by the authorized person or persons submitting the EOI in token of his/their having acquainted himself/themselves with the terms & conditions of contract as laid down. Any bid with any of the documents not so signed will be rejected.

SECTION-B GENERAL TERMS AND CONDITIONS

Upon the declaration of an intending bidder to be the Empanelled bidder by the Institute, they shall be subject to the following terms and conditions.

- 1. The institute shall invite the Limited tenders for works from the empanelled contractors for proposed works under limited tender enquiry.
- 2. In all matters of dispute arising on the work, the matter shall be referred to the **Registrar Indira**Gandhi Institute of Development Research, Goregaon for a decision.
- 3. **Arbitration Clause:** In the event that the Successful Bidder is not satisfied by the decision of the Registrar, Indira Gandhi Institute of Development Research, the dispute shall be settled by arbitration in accordance with the provisions of arbitration and conciliation act, 1996 or any enactment thereof. The Arbitral Tribunal shall consist of one arbitrator, to be appointed by the Institute. The place of arbitration shall be Mumbai and any award whether interim or final, shall be made, and shall be deemed for all purposes between the parties to be made in Mumbai. The arbitration proceedings shall be conducted in the English language and any award or awards shall be rendered in the English language. The procedural law of the arbitration shall be the Indian law. The award of the arbitral tribunal shall be final, conclusive and binding upon the Successful Bidder and the Institute.
- 4. **Period of Empanelment:** The empanelment period shall be for **One (1) year** from date of confirmation of empanelment.
- 5. The application of contractor not meeting the minimum eligibility criteria in EOI document shall not be considered for further evaluation.
- 6. If at any stage, any information / document submitted by the applicant is found to be incorrect / false or have some discrepancy which disqualifies the firm then IGIDR shall take action of Debarment of agency from tendering in IGIDR.

- 7. The bidder should have annual turnover of **Rs. 25.00 Lakh** for last **3** financial years (i.e., FY2018-19, FY2019-20 & FY 2020-21) from the execution of similar work contracts. Bidder should submit Audited Balance Sheets; P&L account statements or Auditor's certificate for turnover of above 3 financial years.
- 8. The bidder should have registered office or branch office located in the territory of districts of Mumbai, Mumbai Suburban, Thane and Navi Mumbai. Submit a copy of relevant address proof.
