### **COMPENSATION AND ALLOWANCES**

- 1. Compensation will be in accordance with the Seventh Pay Commission.
- 2. In addition to salary, the Institute also offers long-term benefits, housing, leave travel concessions, education allowance for children, contribution towards CPF, liberal group medical insurance, group term insurance, and group personal accident insurance.
- 3. Suitable accommodation on campus will be provided based on availability. House rent allowance at applicable rates will be paid in lieu of non-availability of campus accommodation as per Institute norms.
- 4. The Institute provides a three-year block research grant of INR 4 Lakhs, plus an additional INR 1 Lakh seed money for an Assistant Professor with less than 3 years of experience.

### **GENERAL INSTRUCTIONS**

- 1. The Candidates who had applied earlier need to apply afresh, as old applications will not be considered.
- 2. Degrees obtained by the candidate should have been awarded by a recognized University/ Institute. All educational qualification certificates, including the Date of Ph.D. Defense must be submitted. All Experience Certificates mentioning designation, pay, and tenure must be duly signed and sealed by the employer, where relevant.
- 3. Applicants who are employed in Government, Semi-Government, Autonomous Body, or similar Institutions should send their applications through the proper channel. They will be required to produce a No Objection Certificate (NOC) from their employer at the time of the interview.
- 4. Candidates must ensure before applying that they are eligible according to the criteria stipulated in the advertisement. If any candidate is found ineligible at any stage of the recruitment/appointment process or is found supplying false information, S/he will be disqualified, and her/his candidature/appointment will be cancelled.

- 9. The Selection Committee may recommend a higher initial basic pay to deserving candidate(s) with relevant experience and high-quality publications, subject to rules.

## **RESERVATIONS**

- 1. Reservation is applicable as per Government of India rules. The candidates belonging to reserved categories (SC/ST/OBC-NCL/PwD/EWS) are required to attach the Caste/Category/Income certificate in the prescribed format of the Government of India, issued by the competent authority, not below the rank of a Tahsildar or from a first-class Magistrate of the place of domicile of the candidate clearly authenticating the category to which they belong to. The Institute follows the Central list in the case of SC/ST and OBC-NCLs. OBC-NCL certificate should not be older than one year.
- 2. The reservations for differently-abled persons (PwD) candidates are as per the Govt. of India guidelines/rules. However, they shall be required to produce a medical certificate in the prescribed form issued by the competent medical authorities for the purpose of employment.

An EWS candidate shall be eligible for the benefit of reservation and other relaxations, if any, as permissible under the rules as per the Ministry of Social Justice and Empowerment Office Memorandum F.No. 20013/03/2018-BC-II dated January 17, 2019, for reservation of Economically Weaker Sections.
